Article 1/ Subject of the contract

- 1. This Agreement regulates the relations between the Parties involved and their rights and obligations with regard to their participation in actions under the GRANT AGREEMENT for: ERASMUS + Multi-Beneficiary Project, CONTRACT NUMBER 2020-1-SK02-KA205-002449 (hereinafter referred to as the Grant Agreement).
- 2. The grant is awarded under the conditions set out in the special conditions of the Grant Agreement, the general conditions of the Grant Agreement for the project called YC2 Youth Councils Yet Coming (hereinafter referred to as the project).

Article 2/ Duration

- 1. By signing the contract, the partners receive the grant and agree to the implementation of the project. The project lasts from 1.6.2020 to 30.04.2022, included.
- 2. The duration of eligibility of expenditures is set for the duration of the project from 1.6.2020 to 30.04.2022, included.

Article 3/ Obligations of the beneficiary


- 1. Take all measures necessary for the preparation, implementation and proper management of the project, as set out in this contract and its annexes, in accordance with the project objectives as set out in the grant agreement concluded between IUVENTA Slovak Youth Institute and the Beneficiary.
- 2. If they occur, inform and provide the Partner with any changes related to Grant Agreement No. 2020-1-SK02-KA205-002449.
- 3. Define the rights and obligations of both parties, including those related to the allocation of intellectual property rights.
- 4. The partner assumes own part of the material responsibility for the project.

Article 4/ Responsibilities of the partner

The partner undertakes to:

1. Take all measures necessary for the implementation and proper management of the outputs set out in this contract and its annexes, in accordance with the objectives of the project.





Reports

1. The partner will provide the Beneficiary with all information and documents necessary for the preparation of the Interim report at the latest by 15.06.2021, including the period between 01.06.2020 and 30.5.2021.

The documents shall be provided as the originals, based on Article 4, paragraph 3.

2. The Partner will provide the Beneficiary with all information and documents necessary for the preparation of the Final report by 31.5.2022.

Article 9/

Monitoring and controlling

- 1. The Partner shall immediately provide the Beneficiary with all information and documents necessary, concerning the working program for which this contract applies.
- 2. The Partner will provide the Beneficiary with the documents proving that the above-mentioned working program is being carried out.
- 3. The obligations set out in this article of the agreement apply to both the Beneficiary and the Partner.

Article 10/

Termination of the contract

- 1. The Beneficiary may terminate the contract if the Partner has not fulfilled any of the contractual obligations, unless this is due to force majeure. However, this situation occurs after notification to the Partner by registered letter, which has remained ineffective for one month.
- 2. The Partner shall immediately notify the Beneficiary of any event that could threaten the performance of this contract and shall provide all relevant information.

Article 11/

Changes or amendments to the contract

1. Amendments to this contract must be made only on the basis of an addendum to the contract signed on behalf of both of the parties to the contract.
